1. Call to Order/ Roll Call/ Pledge of Allegiance/ Moment of Silence

A regular meeting of the Board of Trustees of the Village of Hatch was held in the Trustees Chambers located at 133 N. Franklin Street, Hatch, NM, on the above date. Mr. Gallegos presented his concerns to the Board of Trustees, as there was a structure fire at 512

Adams Street approximately two weeks ago, and four of his sheds burned down to the ground. There was response from Organ Fire Department and Hatch Fire Department never showed up. He stated that he talked to State Officials and was told that there's grant funds out there. The Village just needs to apply for those grants. Fire Chief Au apologized on behalf of the Hatch Fire Department for not responding, but also explained to Mr. Gallegos that the Hatch Fire Department is all Volunteer, and all its members have full time jobs, and at times cannot respond to emergencies as in this case. Chief Au also made the invitation for new people to join the Fire Department more volunteers are very much needed. Mayor Whitlock said that the Village of Hatch is well aware of this problem and are doing everything that the Village possibly can to help resolve this issue.
