1. Call to Order/ Roll Call/ Pledge of Allegiance/ Moment of Silence

Minutes:

A regular meeting of the Board of Trustees of the Village of Hatch was held in the Trustees Chambers located at 133 N. Franklin Street, Hatch, NM, on the above date. Mayor Whitlock, asked the Clerk Treasurer for roll call as follows: Mayor Whitlock – Present, Mayor Pro-Tem Torres – Present, Trustee Atencio – Present, Trustee Crist – Absent, and Trustee Martinez – Present. There being a quorum, Mayor Whitlock called the meeting to order at 6:00 p.m. Mayor Pro Tem Torres led all in attendance in the pledge of allegiance and Trustee Atencio gave the opening prayer.

2. * Approval of Agenda

Minutes:

Trustee Martinez moved to approve the agenda as presented. Seconded by Trustee Atencio. Motion carried.

During the meeting, Marcia Nordyke inquired about the progress of the new Library construction and sought clarification on the Village's position. Mayor Whitlock provided an update, explaining that the Village has actively been searching for suitable property. The initial choice, priced at

\$490,000, proved to be financially unfeasible for the Village. Consequently, the Village is now exploring an alternative piece of property owned by Hatch Grain, situated near the railroad tracks.

Trustee Atencio moved to accept the resignation of Francisco Lucero as utility worker effective November 26, 2023. Seconded by Trustee Martinez. Motion carried.

10. Department Head Input

Minutes:

Jorge Au, Fire Chief, provided a concise update on the ongoing activities at the Fire Department, including the November schedule for fire extinguisher servicing. He also reported a successful grant application, securing \$150,000 for radios.

Following this, Lisa Neal, Library Director, presented a brief report covering the current programs

and services at the Library.

Chief Thornton shared that operations at the police department are running smoothly. Interestingly, the month began with zero applicants for vacant positions at the police department. Chief Thornton also mentioned upcoming plans for finishing installation of radios and computers within a month.

Mayor Whitlock informed the Board that it's time to consider potential projects for the Village, especially given that this year's Legislature will only have a 30-day session.
