Fire Department Update: • Jorge Au, Fire Chief, provided a brief overview of current activities within the Fire Department. • Radios have been received and are awaiting programming. •

Operations have been ongoing out of Hatch. • Dona Ana County is in the process of acquiring paid staff for Rincon. • Chief Au has resigned from Station No. 6.

Utilities Department Update (Presented by Mike Castillo, Public Works Director): • The fire hydrant at the Fire Department has been repaired. • Seventeen dead trees have been removed by the utilities crew and will be burned. • The pumps at the WIC Department building require replacement, and RT Electric will install wiring for the 220 pumps. • The backhoe in need of repair will cost approximately \$34,000 for a new transmission or \$11,000 to rebuild, as per the mechanic's assessment. • Mayor Pro Tem Torres requested the painting of speed bumps around town for better visibility at night. Mike assured that they will begin this once the weather improves. Police Department Update (Presented by Tim Thornton, Police Chief): • Radios have been successfully installed. • Law Enforcement Protection Funds (LEPF) allocation is planned for expenditure. • Tyler will be installing computers for the recent Management System for reports. • The department is now fully staffed and continues to perform effectively.
