#### Minutes:

Lisa Neal, Library Director, reported that the GO Bond monies received from the state have been utilized to purchase much-needed shelving and implement a new system. This system will enhance patron experience by providing visibility into available books, enabling reminders for due dates, and facilitating event advertising. Additionally, it was noted that Alice Soto will return to work on the second week of May.

Mike Castillo, Public Works Director, updated the Board on various ongoing projects. Efforts have been focused on preparing the pool for the upcoming season, with some delays due to awaited parts. The confirmation group contributed to the community by cleaning up the cemetery, and Public Works facilitated the disposal of collected trash bags, the group did a great job. Progress has been made on the installation of the septic system at the ball fields, with Johnny's Septic currently working on the leash line. The crew has also been engaged in relocating water lines. Hernandez, Chief of Police provided a brief overview of the Police Department's operations, noting smooth functioning. Officers are actively patrolling areas in response to reports of theft, with several returns made. However, challenges arise when victims decline to press charges.
