1. Call to Order/ Roll Call/ Pledge of Allegiance/ Moment of Silence

A regular meeting of the Board of Trustees of the Village of Hatch was held in the Trustees Chambers located at 133 N. Franklin Street, Hatch, NM, on the above date. Mayor Pro Tem Atencio asked the Clerk Treasurer for roll call as follows: Mayor Torres-Absent, Mayor Pro Tem Atencio-Present, Trustee Crist-Present, Trustee Martinez-Present, Trustee Franzoy-Present. There being a quorum, Mayor Pro Tem Atencio called the meeting to order at 6:00 p.m. Trustee Martinez led all in attendance in the pledge of allegiance and Trustee Franzoy gave the opening prayer.

Bernadette Acosta, President of the Chile Festival, provided an update on the planned activities for this year's Chile Festival weekend. A small parade is scheduled as part of the festivities. A carnival will be held, featuring various attractions. Over seventy booths have been rented out to different vendors. A rock hunt is among the activities planned. Volunteers Needed, the festival is currently in need of additional volunteers to assist with various tasks.

Anna Avalos expressed concerns about the condition of certain properties in town. She asked the Board if any measures could be taken to encourage property owners to clean up their spaces. She emphasized the importance of making Hatch proud, especially with the Chile Festival approaching, and noted that it would be beneficial for the town to look clean and presentable for the event.

8. Department Head Input

Minutes:

Fire Chief Jorge Au provided an update on the department's activities for the month. The ongoing ISO documentation updates are in progress. Annual pump testing, apparatus maintenance, SCBA testing, and fire extinguisher testing were all completed in July. However, there have been delays in the delivery of radios and Toughbooks. Hatch FD will be applying for the SFMO grant, which, if awarded, is anticipated to supplement another grant for the design and construction of the new Hatch FD.

Library Director Lisa Neal gave an update on the summer programs offered to children. The Hatch Public Library has submitted its 2023/2024 New Mexico Public Library Annual Report.

Public Works Director Mike Castillo reported that the booster pump at the Hillburn well has failed. Efforts are underway to order parts and restore it to working condition.

Chief of Police Hernandez provided a brief update on ongoing issues at the Police Department.

There were nine arrests this month, including eight misdemeanors and two warrants, out of a total

of 305 calls. Citation disposition included 12 penalties, 20 court appearances, and 46 warnings, totaling 78 citations. Chief Hernandez also followed up on issues raised at the last meeting, stating that the batteries for the speedometer will be ordered this week, with the speedometer expected to be operational soon.
