There being a quorum, Mayor Torres called the meeting to order at 6:00 p.m. Trustee Martinez led all in attendance in the pledge of allegiance and Fr. Ivan Torres gave the opening prayer.

#### 4. Public input

# a. Chantal Orosco & Susan Downs, Caballo Soil and Water Conservation District

#### Minutes:

Chantal Orosco and Susan Downs from the Caballo Soil and Water Conservation District gave a presentation on upcoming grant opportunities that could benefit the Village. They also discussed potential areas of collaboration and sought input on the Village's needs to determine how the District could assist.

Fr. Ivan Torres addressed the Board of Trustees regarding his application for a Conditional Use Permit at 490 Archer Drive. He explained the Church's need to expand due to limited space for weekly activities. The proposed use of the house is to convert it into classrooms for catechism classes for children and youth, which he stated would benefit both the church community and the broader Hatch community. Fr. Torres requested the Board's consideration and approval of his application when it comes before them.

Bernadette Acosta, representing both the Chamber of Commerce and the Chile Festival Committee, reported to the board that plans are underway for the December concert, and the Tree Lighting Ceremony. She mentioned that efforts are ongoing to organize these activities.

# 11. Department Head Input

### Minutes:

Public Works Report: Mike Castillo, Public Works Director, provided an update on ongoing issues within the Public Works Department. He reported that the Rodey Lift Station Project has been completed successfully, with no issues, and that the department is up-to-date on utility applications for new services. The ordered brush hawk has not yet arrived. Christmas decorations are scheduled to be installed in the coming week, with the goal of completion before Thanksgiving. Additionally, the marquee sign is not functioning, but an electrician has been contacted to diagnose and repair the issue.

Police Department Report: Aurora Hernandez, Chief of Police, reported a total of twenty-five arrests, including two felonies, twenty-three misdemeanors, and one warrant. The department also issued twenty-five penalties, twenty-two court appearances, and gave one hundred-fourteen warnings. Chief Hernandez noted that the department is functioning well, has advertised an open

position to fill a vacancy, and continues to work toward improving the Village.

# 12. Mayor & Trustees Input

### Minutes:

Mayor Torres informed the Board of Trustees that he and the Clerk had met with Jorge Au, Fire Chief, to discuss challenges facing the Fire Department, including a lack of volunteers. The Fire Chief also highlighted how the County is transitioning to paid firefighters. Mayor Torres noted that, at some point, the Board will need to decide on the best course of action for the Village regarding the future of the Fire Department.
