position are scheduled for next week. Chief Hernandez also informed the Board that she had just received a call with the unfortunate news that a DASO officer lost his life in a fatal vehicle accident.

Lisa Neal, Library Director, provided an update on Library activities. The Summer Reading Program is ongoing, and the Library is partnering with local schools to support various educational programs.
