Mayor Torres, asked the Clerk Treasurer for roll call as follows: Mayor Torres-Present, Mayor Pro Tem Atencio-Present, Trustee Crist-Absent, Trustee Martinez-Present, Trustee Franzoy-Present. There being a quorum, Mayor Torres called the meeting to order at 6:00 p.m. Trustee Martinez led all in attendance in the pledge of allegiance and Trustee Franzoy gave the opening prayer.

14. Department Head Input

Minutes:

Mike Castillo, Public Works Director, gave a brief report on ongoing issues with the Utilities Department. He reported a major water break in Las Uvas on Sunday that required water service to be shut off for about six hours; service was restored the same day. The break occurred on the main transmission line. He also noted another smaller leak located about five to seven miles back, which will be repaired on Wednesday. Mr. Castillo also reported that someone has been dumping white paint into the sewer system, preventing the Sewer Operator from completing required testing until it clears. Mayor Pro Tem Atencio suggested sending a mailing to all customers informing them of the problem. Mr. Castillo stated they are working to identify the responsible party so it can be stopped. He is also looking into the purchase of a new bucket truck, and the Clerk Treasurer will research grant opportunities to assist with the purchase. Chief of Police Aurora Hernandez reported no major incidents during the Chile Festival weekend, aside from two minor incidents: one medical call and a fight between children that had already ended when officers arrived. She also reported that one officer is currently in training and that the advertisement for the open position has been posted.

15. Mayor & Trustees Input

Mayor Torres reported that the Village has received the grant offer for the Canal Bridge Project and will now work on securing the additional funding needed for completion. He stated that he will be reaching out to the Governor regarding the \$6 million still needed.
