7. \*Resolution No. xxx - Authorizing the execution and delivery of a loan and subsidy agreement ("Loan Agreement") by and between the Village of Hatch, New Mexico (The Governmental Unit") and the New Mexico Finance Authority ("NMFA").

A RESOLUTION AUTHORIZING THE EXECUTION AND DELIVERY OF A LOAN AND SUBSIDY AGREEMENT ("LOAN AGREEMENT") BY AND BETWEEN THE VILLAGE OF HATCH, NEW MEXICO (THE "GOVERNMENTAL UNIT") AND THE NEW MEXICO FINANCE AUTHORITY ("NMFA"), IN THE TOTAL AMOUNT OF THREE HUNDRED TWENTY-FIVE THOUSAND FIVE HUNDRED DOLLARS (\$325,500) ("LOAN") EVIDENCING A SPECIAL LIMITED OBLIGATION OF THE GOVERNMENTAL UNIT TO PAY A MAXIMUM REPAYABLE PRINCIPAL AMOUNT OF NO MORE THAN ONE HUNDRED THIRTY THOUSAND TWO HUNDRED DOLLARS (\$130,200), TOGETHER WITH INTEREST, AND ADMINISTRATIVE FEES FOR THE PURPOSE OF FINANCING THE COSTS OF IMPROVING THE SYSTEM BY CONDUCTING A LEAD SERVICE LINE REPLACEMENT PROJECT AND ASSOCIATED ACTIVITIES DIRECTLY CONNECTED TO PLANNING, DESIGNING AND REPLACING OF LEAD SERVICE LINES, INCLUDING AN INVENTORY/SURVEY TO DETERMINE IF LEAD EXISTS IN THE GOVERNMENTAL UNIT'S WATER UTILITY SYSTEM LINES AND SHALL INCLUDE DRINKING WATER FACILITY CONSTRUCTION PROJECT WORK AND REVISIONS NECESSARY TO COMPLETE THE PROJECT AND SUCH OTHER RELATED WORK AND REVISIONS NECESSARY TO COMPLETE THE PROJECT ("PROJECT"), AND SOLELY IN THE MANNER DESCRIBED IN THE LOAN AGREEMENT. PROVIDING FOR THE PLEDGE AND PAYMENT OF THE LOAN SOLELY FROM THE NET REVENUES OF THE WATER AND SEWER SYSTEM OF THE GOVERNMENTAL UNIT APPROVING THE FORM OF AND OTHER DETAILS CONCERNING THE LOAN AGREEMENT; RATIFYING ACTIONS HERETOFORE TAKEN; REPEALING ALL ACTION INCONSISTENT WITH THIS RESOLUTION: AND AUTHORIZING THE TAKING OF OTHER ACTIONS IN CONNECTION WITH THE EXECUTION AND DELIVERY OF THE LOAN AGREEMENT.

8. \*Consideration and approval of the Splashpad Project Construction Contract Award.

## Minutes:

Bids were opened for the above-referenced project on Tuesday, November 4, 2025 at 10:00 am. The Project includes construction of a new splash pad and new restroom building. The new splash pad will be open to the public on a seasonal basis and will be located within the Hatch Community Center Recreational Park area. The new splash pad and restroom building will serve to enhance this recreational area and will include improved accessibility for the disabled. The project was bid on a lump sum base bid with three additive alternates basis given the known limited funding available. A total of three bids were received before the scheduled bid opening time. A summary of the bids received is shown below:

Las Cruces Construction, LLC Fairacres, NM Total base bid - \$1,052,028.00; Additive Alternates - \$828,891.00; Total base bid and additive alternates \$1,880,919.00

Highland Enterprises, Inc. Las Cruces, NM Total base bid - \$1,284,390.00; Additive Alternates; \$1,004,411.00; Total base bid and alternates \$2,288,801.00

Morrow Enterprises, Inc. Las Cruces, NM Total base bid - \$1,425,783.00; Additive Alternates - \$1,170,889.00; Total base bid and additive alternates \$2,596,672.00

Mayor Pro Tem Atencio moved to award the Splashpad Project construction contract to Las Cruces Construction, LLC for the total base bid in the amount of \$1,052,028, excluding NMGRT. Seconded by Trustee Franzoy. Motion carried.

# 16. Department Head Input

# Minutes:

Lisa Neal, Library Director, provided a brief update on the library. She noted that the Trunk or Treat event was a success and that staff is now working on holiday

programming. She also reported that the library's annual report for this year has been submitted.

Trey Gimler, Chief of Police, reported on Police Department activity. There were a total of 327 calls for service, 27 of which belonged to DASO. Due to DASO being short-staffed, Hatch Police officers have been assisting until a deputy arrives, with wait times reaching up to one hour in some instances. The department issued 156 citations, had 51 court appearances, 9 penalties, 7 arrests, and 3 felony cases. Chief Gimler stated that he contacted METRO, and they are now assisting the department with investigations. He also reported that the evidence room was cleaned and NIVEN tested all firearms; two of the firearms returned results linking them to a shooting in Arizona.

# 17. Mayor & Trustees Input

#### Minutes:

Mayor Torres reported that efforts continue to get the rest of the funding for the Canal Road bridge project so he will be attending a Legislative Priorities Forum for Dona Ana County Entities.
